## About this form

You can use this form to contribute to your spouse's account in Catholic Super. You will need to complete this form each time you wish to make a spouse contribution into Catholic Super. There are limits to the amount of contributions that can be made before penalty tax may be applied.

### 1 – Spouse contribution eligibility

Please complete in pen using CAPITAL letters

For Catholic Super to accept a contribution, you need to confirm your eligibility below. Please call us before making a contribution if you do not meet these conditions.

#### You must meet the following conditions

- We are married or we live together on a genuine domestic basis
- We are both Australian residents for tax purposes
- The receiving spouse is under the age of 75
