Tell your employer of your choice of super fund

- You may need to give your employer our details: **USI:** 50 237 896 957 601 **ABN:** 50 237 896 957
- **OR** complete the Choice of Fund Application form available at csf.com.au/forms, then give the completed form to your employer.

Transfer any existing insurance

Insurance cover that you currently hold may be added onto the cover that Catholic Super provides, when you join the fund.

Insurance costs may vary, but this means you don't need to reapply to keep the same cover. To do this:

- Login to MyLife Online at csf.com.au/mylifeonline using the login details we will send you. In the Insurance section, click the Apply For Insurance Online button and follow the steps.
- **OR** download, complete and return the Insurance Transfer form, available at csf.com.au/forms

Group your super together

When you have super in an account that you're not adding to, it can be eroded by fees. You may also have lost track of your super when moving house, changing jobs, or if you changed your name. There are several ways to get your super together:

- Login to MyLife Online at csf.com.au/mylifeonline, and click the 'Super Grouper' button in the 'Your super' section.
- **OR** call us on **1300 655 022** and our Superannuation Specialists can do it for you over the phone.
- **OR** download, complete and return the Request to Consolidate Your Super form, available at csf.com.au/forms
